Privacy Policy

Venous-lymphatics World International Network (vWIN) not for profit Foundation (legal head office: Rovigo via Mazzini 12, 45100), legally represented by Sergio Gianesini, according to the European Data Protection Regulation (GDPR) 679/2016, provides the following information

1. DATA Treatment aims

Data treatments aims are:

- a. Educational content updates;
- b. Recipient of communications regarding scientific and educational v-WIN initiatives;

2. DATA treatment legal base

Treatment legal base is identified as per art.1 letter a., b., c. with the intent of pursuing the legitimate interest of the holder, as per the art. 1 letter d with the free consent as expressed by participant.

3. DATA treatment mode

Your data are collected both manually and electronically for the purposes above reported and in full observation of the current legislation, including safety profiles and confidentiality, following the principles of correctness and lawfulness.

4. Knowability field and data communication

Personal data can be shared with:

- a. Webmaster for database management
- b. Providers dealing with personal data according to the legislation and eventual subproviders with a specific assignment in case of activities related to the above mention points, with the aim of performing further data management according to the aims for which data were collected.
- c. With the aim of performing further treatment according to the aims for which the data were originally collected.

The subjects acting on behalf of the holder are designed as responsible for the treatment as per art. 28 of the regulation, of which the entire text can be requested to the holder.

Moreover, personal data can be shown to v-WIN authorized personnel as per art. 29 of the regulation.

5. DATA transfer

Management and storage of personal data is on servers inside the United Europe, of the holder and/or third assigned parties and properly nominated as treatment responsible.

Currently, the servers are in Italy. Data are not currently transferred outside the United Europe. In case of necessity, the holder can move the server localization from Italy inside or outside the United Europe. In this case the holder ensures that the transfer of data outside the United Europe will happen according art 44 of the regulation and according to the current legislation, stipulating, if necessary, agreements for adequate data protection.

6. DATA storage timing

The data will be stored according to the legislation, for a time not superior to the needed one for achieving the aims for which they were collected or until the consent revocation, this one not affecting the lawfulness of the previously performed treatment.

7. Rights of the data owner

We inform that in any moment the data owner can express the right as per art. 15, 16, 17, 18, 20, 21 & 22 of the regulation. Specifically, the data owner has the right to obtain confirmation of existence or not of the data and in case to obtain access to the same data, verifying their correctness. Moreover, the data owner has the right of requesting the rectification of the data, the cancellation, the treatment limitation, the portability of the data and of counteracting all or part of the data sharing for legitimate reasons, of revoking the consent, and of delivering a complaint to the Control Authority.
